MEMORANDUM OF ASSOCIATION

- The name of the Society is International Society for Krishna Consciousness.
- 2. The Registered office of the Society shall be situated C/o. Kailash Seksaria, 74, Marine Drive, Bombay 20.
- 3. The objects for which the Society is established are:
 - To advance, transmit, spread and propagate the religion of Krishna Consciousness as revealed in the teachings of the Diagavad Cita and Shrimad Chagwatem and the doctrines and observances that serve to promote and manufest the said religion and in furtherance of this object but not otherwise the society shall have the following powers:
 - To educate the public generally is an awareness of Krishna and to develop the proposition that each sould be part and parcel of the quality of Godhead (Krishuna).
 - (b) To teach and encourage the Samkirtan movement, congregational chanting of the Holy Name of God and revealed in the teachings of Lord Sri Chaitanya Majaprebhu.



- cendental pastimes, Temples, schools, colleges, hosp tals or other buildings in connection with and for the advancement of the objects of the Sockety, and to maintain alter and improve the name, including existing buildings, and to furnish and equip the same.
 - (d) To teach a simpler and more natural way of life.
 - the Bhagaved Gita and the Shrimad Bhagwatam and the doctrines that sanifent the religion of Krishna consciousness by television, the secondings, sound braodcasting, cinematograph films, gramphone recordings and recitals and by any other system of sound or picture reproduction whatsoever, or by public meetings, lectures, serivces, acrooms, addresses, rallies, missions, revivals or peaceful or needes.
 - (f) To print, publish, sell or cause to be printed published, sold or if thought fit, to distribute gratuitously books; booklets, leaflets, daily, weekly, monthly, quatterly or yearly newspapers, magazines, or other periodicals for the purpose of giving information in regard to the work of the Society.
 - (g) To purchase, take on leave or exchange, hire or otherwise acquire any real or personal property and any rights or privilleges which the Society any think necessary for the promotion of the objects, and to construct, maintain and alter any buildings or erections necessary for the work of the Society.

To mell let martage, diennee of or turn to



account all bramy of the property or assets of the Society.

- (i) To undertake and execute any charitable trusts which may lawfully be undertaken by the Society.
- (j) To invest the moneys of the Society not immediately required for its purposes in or upon, such investments, securities or property as may be thought fit, subject nevertheless to such conditions (if any) and such consectiff any) as may for the time being be imposed or required by law and subject also as herein agent provided.
- (k) To establish and support or aid in the establishment and support of any charitable associations or institutions and to subscribe or guraantee money for charitable purposes in any way connected with the purpose of the Society.
- (1) To do all such other things as shall further the attainment of the objects of the Society.

Provided that :-

1

(1) In case the society shall take or hold any property which which may be subject to any trusts, the Society shall only deal with or invest the same in such manner as allowed by law, having regard to such trusts.

(11) The society shall not support with its funds any object, or endeagour to impose on or procure to be observed by its members or others any regulation.

Society would make it a Trade Union.

- (iii) In case the Scolety shall take or hold any property su to the jurisdiction of the Charity Commissioners or othe authority in any State the Society shall not sell, mortage charge or lease the same without such authority, approval or consent as may be required by lae, and as regards any such property the Council of Management or Governing Body of the Society shall be chargeable for any such property that may come into their hands and shall be answerable and accountable fee their own acts, receipts, beglects and defaults, and for the dus administration of such property, in the same manner and to the same extent as they would as such Council of Managament or Governing Body have been if no incorporation had been effected, and the incorporation of the cociety shall not diminish or impaor any control or authority exercisable by the Charity Commissioner or other authority in any State but they shall as regards any such property be subject jointly and separately to such control or authority as if the society were not incorporated.
 - by the Society over its exepnses will be applied solely for the promotion of the objects of the Society as set forth above, and no portion thereof shall be paid or transferred directly or indirectly by way of dividends, bonuses or otherwise howsever by way of profit to any member or ex-member or any other person claiming through them or any of them provided that nothing herein contained shall prevent the payment in good faith of remuneration to any officers or servants or employees or other persons of the Society in return for any services rendered to the Society irrespective of the fact whether such officer, servant, employee or other person of the Bociety is a member of the Society or not.



- 5. The full management and control of the affairs of the Society shall be entrusted to and vest in the Bureau of the Society.
